FRANKLIN, Mich. – Just days before the Barry Levinson movie “You Don’t Know Jack” debuts on HBO (April 24<sup>th</sup> at 9 p.m. and April 25<sup>th</sup> at 2:45 a.m.), nationally known attorney Geoffrey Fieger spoke with Scott Weinberg on the CBS Radio Sunday morning legal show, Weinberg on the Law.

“I advise all young lawyers that if their desire in life is to make a lot of money, then they’re in the wrong profession,” said Fieger last Sunday. “They won’t be happy. And that’s true of any profession. It wouldn’t hurt young lawyers to go work in public defender’s offices or to take criminal appointments.”

“It doesn’t matter what you earn when you come out of college,” said Weinberg. “It’s the experience you get

“If you love what you do, you’ll be successful,” says Fieger. “If you don’t love what you do then you shouldn’t be doing it.”

“It was an honor and privilege to connect with one of our nation’s greatest lawyers,” says Weinberg. “And we are so lucky to have Fieger Law in our own backyard. It’s an example of the kind of charisma and determination that comes out of Michigan.”

Geoffrey Fieger is one of the most successful trial lawyers in the country. His charismatic personality made him the star of the Fox series *Power of Attorney* and of the CBS radio program, *Fieger Time*. He appears regularly on CNN, Fox, MSNBC and other networks commenting on various legal issues and cases. He has won more multimillion-dollar awards than any other attorney in the country, including his very first trial. Some of his cases include the defense of [Dr. Jack Kevorkian](#), and [Nathaniel Abraham](#) – the youngest person ever tried for murder as an adult in the U.S.

Scott Weinberg has represented teens accused of assaulting their parents, women accused of involving kids in sex scandals and celebrities accused of driving too fast. Any criminal offense on the books, Weinberg’s defended it. Since March, he’s been sharing his expertise in criminal law via the air waves with his weekly show, “Weinberg On the Law,” which airs on CBS Radio WXYT 1270 AM Sundays at 9 a.m.

Weinberg has interviewed an array of local leaders and lawyers while also discussing important timely matters related to the law and citizens' rights.

"In two decades of practicing law, I've seen and heard just about everything," says Weinberg, managing partner of Weinberg Law. The firm serves clients throughout the state of Michigan and will next year expand into Illinois. "It's an honor to be able to offer what I've learned to keep others safe and out of jail."

Weinberg manages a dozen attorneys in defending clients on a variety of criminal offenses. Before he founded Michigan Criminal Lawyers PC in 1997 (which now operates under the name Weinberg Law), he worked with Bill Bufalino for 10 years and before that, was a prosecutor in the Macomb County Prosecutors Office.

He has been an expert guest commentator on Court TV, WWJ and WXYT radio for noted cases like People v. Jack Kevorkian, the Jenny Jones murder case, Dr. People v. Donald Debolt and People v. Watts. He is also a regular guest on Infinity Broadcasting stations including WXYT, WWJ and WJR.

Weinberg is a graduate of University of Michigan and University of Detroit School of Law and a member of the Michigan and Illinois State Bar Associations.
